RULES



The competition will be run online. Entries will be displayed on the Australian Bee Congress Facebook page and during the Congress.

Categories

There will be four categories of the digital photographic competition:

- **Close up** - bees up close, bees and flora, in the hive (honeycombs, brood combs, pests and diseases, manipulation techniques).
- **Scenic** - moving hives, hives in the landscape, decorated hives and swarms.
- **People and Bees** - beekeepers and their hives
- **Open** - storyboard and edited photos

Entry limitations

- The competition is open to all attendees of the congress.
- For each category entrants may not enter more than two entries.
- The same photo cannot be entered into 2 different categories.
- Submitted photos will be accepted for the competition on the understanding that they have been taken (and, if necessary, manipulated) by the entrant.
- AHBIC reserves the right to reject any entry deemed inappropriate.
- Entries close at midnight on 31 May 2022.

Submission

- Only digital entries will be accepted, via the congress website - www.australianbeecongress.com.au/competitions
- Each digital photo should be submitted in jpeg format
- Receipt of entries will be acknowledged by email.
- Except during the judging process and slideshow, entries will not be distributed to other persons without the permission of the entrant.
- By entering you are giving AHBIC authority to use your image.

Judging

The judging will take place prior to the Congress and the winners will be announced at the Congress Dinner on Saturday 11 June. The congress chair, Shona Blair, will have the casting vote if required.

Terms & Conditions

1. The competition is run by Australian Honey Bee Industry Council Incorporated (AHBIC). (ABN 63 939 614 424), PO Box 42, Jamison Centre, Macquarie ACT 2614
2. Each photographer retains copyright of his or her images, and the entrant authorises AHBIC to display, print, distribute and use in any manner any photographs entered in this competition, for any purpose, in perpetuity.
3. The entrant must be the copyright owner of any images he/she enters into the competition.
4. Any post-production and editing must be the work of the entrant.
5. The entrant is responsible for obtaining all relevant model and/or property releases.
6. The entrant indemnifies AHBIC against any claim, legal or otherwise, that may arise out of publication of the image.
7. By entering the photograph into this competition the entrant guarantees to AHBIC that the above entry requirements have been met.
8. For the purposes of Australian law, this Photo Contest is a 'game of skill' and chance plays no part in determining the finalists or winners.
9. The winner of the competition will be selected by a panel nominated by the Congress Chair. The judge's decision is final and no further correspondence will be entered into.
